The Centers for Medicare & Medicaid Services (CMS) mandate for compliance with any particular edition of the National Fire Protection Association's Life Safety Code (NFPA 101) is no simple thing, and as if published code requirements aren't elusive enough, CMS mixes it up with its own requirements for adoption. This session explores fundamental CMS requirements for an ASC's physical (built) environment, from CMS facility-related mandates to the design, construction and operational requirements of the adopted "Life Safety Code set." CMS & NFPA requirements for ASCs and little known operational requirements that can quickly turn a survey into a nightmare will be highlighted. New Life Safety Code code sets will be discussed.

Innovation and research continue to redefine sterilization standards and recommended practices, and surveying agencies are intensifying their oversight of these processes in the ASC setting. - the first guidance document that addresses loaner instrumentation, Technical Information Report (TIR) 63 Management of loaned critical and semi-critical medical devices that require sterilization or high-level disinfection.

#### Compounded Medicines—New Laws, New Responsibilities and New Questions

In 2012, a Massachusetts compounding pharmacy distributed 17,000 doses of a sterile injectable drug. Some of those vials were contaminated, and more than 65 people died. Another 745 were infected. Neither the state regulatory board nor the Food and Drug Administration, which had both inspected the facility and found significant deficiencies, took action or responsiblility. A year later, to clarify federal oversight and authority, Congress passed the Drug Quality Security Act. This law applies not just to pharmacists, but to all physicians and prescribers. Get an overview of the new law, its impact on practice and what ASCs need to know now to establish a responsible relationship with a compounding pharmacy.

#### The Feasibility, Safety and Effectiveness of Minimally Invasive Transforaminal Lumbar Interbody Fusions Performed in an Outpatient Setting

While numerous studies demonstrate the safety and effectiveness of reducing pain and disability levels among patients who undergo minimally invasive spinal fusions, no formal studies conducted to date report on the safety and effectiveness of minimally invasive transforaminal lumbar interbody fusions (TLIF) performed as outpatient procedures. This pilot study evaluated the feasibility of performing a minimally invasive single-level TLIF in an outpatient setting. It indicates that as the result of new techniques that allow for significant reductions in levels of pain and disability, low blood loss and low rates of complications, it is feasible to

perform a TLIF safely in the outpatient setting today.


